Membership Information and Practice Session Rules/Regulations

1. The membership fee is a one time charge of \$150/member (membership payments are only being accepted through our website at www.burlesoncountysaddleclub.com)
2. This membership applies within the term of January 1, 2026 - December 31, 2026.
3. Members must be above the legal age of 18.
4. You must be a **paid** BCSC member to reserve the arena for practice sessions.
5. Members must sign the "WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT" PRIOR to reserving the arena.
6. Practice sessions are Monday-Thursday in 3 hour time increments from 8am-11pm (8am-11am, 11am-2pm, 2pm-5pm, 5pm-8pm, 8pm-11pm)
7. If no event is scheduled for Friday-Sunday then the arena will be available for practice sessions during the same time increments as above.
8. Practice sessions are \$20/session.
9. The light charge of \$30/session applies if arena lights are utilized at any time during the session.
10. Members are not allowed to reserve the arena more than 3 times/week.
11. Members are allowed 1 back to back session/week, (6 hour time block)
12. Practice sessions can only be reserved 2 weeks in advance.
13. Members may allow members or non-member riders/participants to join their practice session as guests. The fee for each guest riding/participating in another member's practice session is \$10 per rider/participant. The member reserving the session is responsible for non-member riders/participants paying. All non-member riders/participants utilizing the arena during a members practice session must sign the "WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT" waiver PRIOR to using the arena. The member reserving the session is responsible for non-member riders/participants signing this waiver. Leave money and liability form(s) in the black lock box under stairs.
14. Members are only allowed to reserve practice sessions through the Sign Up Genius access given to them.
15. BCSC implements a "3 strike" system for the reserving of practice sessions. If any member breaks or abuses these rules 3 times, the BCSC holds the right to review this person's membership. BCSC also holds the right to strip this person of their membership, said member will forfeit their membership fee and any practice session fees.
16. BCSC holds the right to invoice any member who has not paid their practice fees or non-member fees. If invoice has not been paid within 2 weeks from date of invoice, the member runs the risk of being stripped of their membership and can potentially forfeit any and all paid fees.
17. If a member chooses to cancel a practice session after already paying their practice session fee, the member will forfeit their practice session fee and any transaction fees. All sales are final and BCSC will not give refunds for any member's decision to cancel at any time.
18. Members will only be allowed to pay for practice sessions via the Sign Up Genius access given to them. If you need to pay for non-member riders/participants then that can be
19. Members will only be able to pay for practice sessions via Sign Up Genius. Sign Up Genius charges a service fee equal to 5% of the total amount plus \$0.50 transaction fee. Members will be responsible for any charges while using the Sign Up Genius payment method.
20. Only the household family of the member (spouse, children under 18 years old, and residents of the household under the age of 18) are eligible to ride free of charge during members practice sessions.
21. If a member or non-member has a question, comment, or concern about Sign Up Genius or the practice session, they are to contact Missy Flencher. +1 (979) 203-6560
22. BCSC has the right to change these rules at any given time. If a change is made to this agreement then all members will be notified (via text or email) no more than 3 days after the change. BCSC reserves the right to add additional restrictions and may membership for any reason at its own discretion.
23. BCSC holds the right to revoke membership at any time without notice at the sole discretion of BCSC.
24. BCSC holds the right to refuse any person the opportunity to become a member.
25. Members must sign and agree to these rules and regulations PRIOR to reserving the arena for practice sessions. By signing you have read and agreed to all rules set forth in this document.
26. Members are to leave the arena and grounds as they found it and ready for the next practice session. With the exclusion of dragging the arena.
27. The grounds keeper of BCSC has the right to tell any person(s) on BCSC grounds to leave if they are breaking or abusing any of these rules.

Member(s) hereby acknowledges that its leasing of the Burleson County Saddle Club Arena (aka Buddy & Edile Lightsey Arena) (collectively referred to herein as the "BCSC Arena") is totally at its own risk and that injuries or personal property damage may occur. Member(s) hereby does agree to release and hold harmless the BCSC Arena their officers, directors, members, affiliated organizations and others acting on its behalf, from any claim, legal liability, legal action or right for damages, for any accident which may occur to them or any equine or other animal that may become injured. Member(s) further assumes and accepts full responsibility for any property and/or livestock placed at the BCSC Arena, or any part thereof, and the Member(s) hereby does release and discharge the BCSC Arena from any and all liability for loss, injury, or damages to the persons or property that may be sustained by Member(s) use of the BCSC Arena.

UNDER TEXAS LAW (CHAPTER 87, CIVIL PRACTICE AND REMEDIES CODE), A FARM ANIMAL PROFESSIONAL IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN FARM ANIMAL ACTIVITIES RESULTING FROM THE INHERENT RISKS OF FARM ANIMAL ACTIVITIES.

IN CONSIDERATION OF the usage of the BCSC Arena by Member and in exchange for the releases herein relating to risk of injury that exists while participating in BCSC Arena (hereinafter the "Activity"); and

I HEREBY, for myself, my heirs, executors, administrators, assigns, or personal representatives (hereinafter collectively, "Releasor," "I" or "me"), which terms shall also include Releasor's parents or guardian if Releasor is under 18 years of age), knowingly and voluntarily enter into this WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT and hereby waive any and all rights, claims or causes of action of any kind arising out of my participation in the Activity; and

I HEREBY release and forever discharge BCSC Arena, located at 905 TX-36, Caldwell, TX 77836, their landowners, officers, employees, helpers, contractors, affiliates, directors, managers, members, agents, attorneys, staff, volunteers, heirs, representatives, predecessors, successors and assigns (collectively "Releasees"), from all claims, injuries or damages that I may suffer as a direct result of my participation in the aforementioned Activity.

I FURTHER AGREE to indemnify, defend and hold harmless the Releasees against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought by me or anyone on my behalf, including attorney's fees and any related costs.

I FURTHER ACKNOWLEDGE that this Activity may involve a test of a person's physical and mental limits and may carry with it the potential for death, serious injury, and property loss. I agree not to participate in the Activity unless I am medically able and properly trained, and I agree to abide by the decision of the BCSC Arena, officials or agents, regarding my approval to participate in the Activity.

I RELEASE, DISCHARGE AND PROMISE NOT TO SUE BCSC Arena, and Releasees, for any loss, liability, damages, or cost whatsoever arising out of or related to any loss, damage, or injury (including death) to my person or property. Release the Releasees from any claim that such Releasees are or may be negligent in connection with my riding experience or ability including but not limited to training or selecting horses, maintenance, care, fit or adjustment of saddles or bridles, instruction or riding skills or leading and supervising riders. **I FURTHER ACKNOWLEDGE** that any animal may, without warning or any apparent cause, buck, stumble, fall, rear, bite, kick, run, make unpredictable movements, spook, jump obstacles, step on a person's feet, push or shove a person, all of which causes serious injury or death. Steel panels, fencing, gates, ropes, latches, saddles, bridles and all other equipment and structures and improvements to the rodeo grounds may loosen or break, all of which may cause serious injury or death.

I ACKNOWLEDGE THAT ANIMAL HANDLING IS AN INHERENTLY DANGEROUS ACTIVITY AND INVOLVES RISKS THAT MAY CAUSE SERIOUS INJURY AND IN SOME CASES DEATH, because of the unpredictable nature and irrational behavior of animals, regardless of their training and past performance. I voluntarily assume the risk and danger of injury or death inherent in the use of the animals, equipment or gear.

I HEREBY CERTIFY that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else Releasor agrees to bear the costs of such injury or damage, further certify that they are willing to assume the risk of any medical or physical condition they may have.

I FURTHER ACKNOWLEDGE that this document is a contract and agree that if a lawsuit is filed against BCSC Arena or its land owners, agents, employees, helpers, members, contractors, directors, horse owners, guides or wranglers for any injury or damage in breach of this contract, the Undersigned will pay all attorney's fees and costs incurred by BCSC in defending such an action.

I AM VOLUNTARILY PARTICIPATING IN THE FOREMENTIONED ACTIVITY AND I AM PARTICIPATING IN THE ACTIVITY ENTIRELY AT MY OWN RISK. I AM AWARE OF THE RISKS ASSOCIATED WITH PARTICIPATING IN THIS ACTIVITY, WHICH MAY INCLUDE, BUT ARE NOT LIMITED TO: PHYSICAL OR PSYCHOLOGICAL INJURY, PAIN, SUFFERING, ILLNESS, DISFIGUREMENT, TEMPORARY OR PERMANENT DISABILITY (INCLUDING PARALYSIS), ECONOMIC OR EMOTIONAL LOSS, AND DEATH. I UNDERSTAND THAT THESE INJURIES OR OUTCOMES MAY ARISE FROM MY OWN OR OTHERS' NEGLIGENCE, CONDITIONS RELATED TO TRAVEL TO AND FROM THE ACTIVITY, OR FROM CONDITIONS AT THE ACTIVITY LOCATION(S). NONETHELESS, I ASSUME ALL RELATED RISKS, BOTH KNOWN AND UNKNOWN TO ME, OF MY PARTICIPATION IN THIS ACTIVITY. I HEREBY ACKNOWLEDGE THAT I HAVE CAREFULLY READ THIS "WAIVER AND RELEASE" AND FULLY UNDERSTAND THAT IT IS A RELEASE OF LIABILITY. THIS WAIVER AND RELEASE OF LIABILITY SHALL REMAIN IN EFFECT FOR THE DURATION OF MY PARTICIPATION IN THE ACTIVITY WITHIN THE 2024 CALENDAR YEAR, DURING THIS INITIAL AND ALL SUBSEQUENT EVENTS OF PARTICIPATION.

I, THE UNDERSIGNED PARTICIPANT, AFFIRM THAT I AM OF THE AGE OF 18 YEARS OR OLDER, AND THAT I AM FREELY SIGNING THIS AGREEMENT. I CERTIFY THAT I HAVE READ THIS AGREEMENT; THAT I FULLY UNDERSTAND ITS CONTENT AND THAT THIS RELEASE CANNOT BE MODIFIED ORALLY. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT. I AM AWARE BY SIGNING THIS CONTRACT I AM ACCEPTING ALL TERMS AND CONDITIONS SET FORTH ABOVE. I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT; FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE, OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY
